## Full Waiver, Release, Assumption of Risk, and Indemnity Agreement

In consideration for the acceptance by the Waverly Futbol Club ("WFC") of the above-named player, ("Player") and his/her parent's or guardian's request and/or application to participate in events, athletic or otherwise, sponsored, sanctioned, or participated in by WFC and the provision of coaching of the Player by WFC, the Player and his/her parent or guardian ("Parent") undertake and agree as follows:

1. Player and Parent acknowledge and accept that there are certain inherent dangers associated with participation in WFC events, including, without limitation, participation in indoor and outdoor soccer practices and competitions, and travel to and from those practices and competitions.
2. Player and Parent acknowledge and accept that WFC does not provide or maintain insurance of any kind whatsoever, including, insurance which would cover the cost of any medical or dental services or therapy arising from participation in or presence at a WFC event.
- ( 3. Player and Parent acknowledge and accept that the Michigan State Youth Soccer Association does not provides secondary insurance and any claims must be filed in accordance with MSYSA policy. )
4. Player and Parent agree to assume all risks and hazards of injury to Player and/or Parent in the course of a WFC event, including, but not limited to, injury caused by physical contact with other participants or person's present, physical exertion, or playing conditions, including field conditions.
5. Parent and Player, on behalf of themselves and their assignees, agree to release and hold harmless WFC from any and all liability and expense, including litigation costs and attorney fees arising out of any and all claims which Parent and/or Player may have. Parent and Player agree to waive any and all claims they may have against WFC, or any of its directors, officers, officials, employees, coaches, representatives or agents (" WFC affiliates"), which may arise as a result of the Parent and/or Player's participation in or presence at a WFC event (including any transportation to and from the event) including any claims arising from any facilities provided directly or indirectly by WFC.
6. Parent and Player shall hold harmless and indemnify WFC and WFC affiliates from any and all claims, liabilities, and expenses arising out of claims brought by third parties in connection with any acts or omissions of the Player and/or any Parent, sibling or other relative of the Player who attends or participates or is present at a WFC event.
7. Parent and Player acknowledge that this document operates as to any WFC event now scheduled or to occur in the future and for which Player is present or participating regardless of team, participants, facility or location.
8. Parent and Player grant WFC permission to use, without compensation, their image, likeness or voice in connection with any promotional materials including, but not limited to, brochures, advertising and broadcasts.
9. This agreement shall be governed by the laws of the State of Michigan and the laws of the United States of America.
10. Player and Parent acknowledge and agree that they have the option of not applying for Player participation in WFC, and of Player not participating in WFC events, if the terms of this document are not acceptable.
11. By his or her signature below, Parent avers that he or she is the legal parent or guardian of the Player named above and has legal authority to enter into this Waiver, Release and Indemnity Agreement on behalf of the Player and on behalf of any other Parent and/ guardian of the Player.
- 12. PARENT AND PLAYER HAVE READ THE TERMS OF THIS AGREEMENT AND THEY UNDERSTAND AND FULLY AGREE TO THE SAME AS BINDING UPON THEM, THEIR HEIRS AND PERSONAL REPRESENTATIVES.**
